**** THE FOLLOWING WAIVER MUST BE SIGNED BY EACH PARTICIPANT: (THIS IS A SCARY THEMED RACE!!!! THERE WILL BE ZOMBIES & CLOWNS)**

I know that running / walking is a very strenuous & potentially hazardous activity. I realize that I should not enter & participate unless I am medically able & properly trained. Knowing this, I certify that to the best of my knowledge, I am in excellent physical condition & have no medical condition that could likely worsen by participating in this event. Furthermore, I certify that I have trained properly for this event & agree to abide by the rules set by race officials, as well as determination on my participation from race officials for this event.

I am fully aware & assume all risks associated with participating with this event, including but not limited to falls, contact with other race participants, race volunteers, zombies, mass murders with chainsaws, creepy stuff & scary clowns. The effect of the weather (rain, snow, wind, atomic fall out), and I appreciate and assume all risks associated with the presence of vehicular traffic while on all roads, levi, and parking lots while on the race course. I am also fully aware that that I am solely responsible for my safety & wellbeing traveling to and from all events associated with the Haunted Barn & 5K Creepy Crawler Fun Run.

In addition, I fully understand that wearing of head phones while participating in this event could be potentially hazardous to my safety. I further understand that sponsoring organizations & entities have recommended against wearing of headphones while participating in this event.

I understand that I will not hit, kick, stab, choke, push, punch, or destroy any of the volunteers; they are living-breathing people here for your enjoyment for a good cause.

Having read this waiver & knowing all the facts and in considering you accepting my entry, I for myself & anyone entitled to act on my behalf, waive & release the Marengo Haunted Barn/Friends of Marengo, the city of Marengo, the Iowa County Conservation Board, the race coordinators, race officials, race organizers, the race volunteers, race sponsors, their representatives, their successors, or assignees, zombies, crazy mass murders with chainsaws, and scary clowns from any & b all liabilities & claims of liability, injuries, death, and damaged property, for all injuries (mental, physical, emotional) to me and/or my property for arising out of/or in connection with my participation, including without limitation to the matters described in the preceding paragraphs. This waiver extends to all claims of any kind or nature, whether foreseen or unforeseen, known or unknown. Furthermore, I grant permission to all foregoing organizations & entities to use any photographs, motion pictures, recordings or any other record of this event for legitimate purposes.
